<u>The Conviction Review Unit of the Broward State Attorney's Office is looking</u> <u>to select members for our Independent Review Panel</u>

- 1. The Conviction Review Unit (CRU) is looking for esteemed members of our community to sit on rotating panels of five to review cases presented for actual claims of innocence.
- 2. The Independent Review Panel (IRP) will represent a diverse mix of citizens from Broward County.
- 3. We are selecting IRP members who have extensive experience as criminal defense attorneys, former prosecutors, former law enforcement, and community leaders with some criminal law knowledge.
- 4. All applicants must reside in Broward County.
- 5. The IRP will be comprised of members who are willing to perform their duties pro bono for the benefit of our community.
- 6. IRP members will be screened for potential conflicts of interest.
- 7. IRP members are selected and serve at the pleasure of the State Attorney.
- 8. The IRP is empaneled as a fact-finding body whose role is to make recommendations to the CRU and the State Attorney.
- 9. IRP members will convene at the CRU attorney's request. If an exoneration or any other corrective action is requested, there must be a majority vote of that five-person IRP.
- 10. The State Attorney will have the ultimate decision-making authority regarding what actions are appropriate in each case.
- 11. IRP members hold a position of public trust and may be privy to sensitive materials that may or may not be subject to public records. They must make diligent efforts to keep confidential records private and respect victims' rights under the Florida Constitution.

Important: To facilitate the effective review process of some claims, the CRU attorney may convene a meeting of the IRP once a case is ripe for review. The IRP will be provided a report generated by the CRU which sets forth the learnings from the CRU's investigation. The IRP may solicit additional information or investigation from the CRU and may meet as a body to discuss the case, and otherwise act as necessary for the IRP to evaluate the investigation and provide information to the State Attorney deemed relevant and necessary for his/her decision making. The IRP is tasked with evaluating the investigation conducted by the CRU to determine if the evidence and information provided supports a claim of actual innocence. The IRP ensures that the State Attorney has the information that he/she needs to make the ultimate decision with regard to resolution of the CRU investigation. Following the IRP's review of the case, a memorandum will be provided to the State Attorney setting forth the IRP's analysis as to a recommendation and any additional information the IRP considers relevant to the State Attorney's ultimate decision. All decisions are at the sole discretion of the elected State Attorney and/or the Executive Staff.
