(1) Summary of charges in the indictment:

Trayvon Key, aka HMTTRAY, is charged with:

Count 1: first-degree murder in the shooting death of Wisdom Williams, aka Wiz da Wizard, on Sept. 16, 2021, to benefit, promote, or further the interests of a criminal gang.

Kevaris Johnson, aka Orkvaris, is charged with:

Count 2: first-degree murder in the shooting death of Antjuan Dobard, aka Sauce, on April 9, 2023, to benefit, promote, or further the interests of a criminal gang.

Count 3: first-degree murder in the shooting death of Terri McKenzie, on May 9, 2023, to benefit, promote, or further the interests of a criminal gang.

Count 4: first-degree murder in the shooting death of Vernaldo Donner, on May 9, 2023, to benefit, promote, or further the interests of a criminal gang.

Jared McCabe, aka Hatch, and **Sigmund Brown, aka Liberia Sig**, are charged with:

Count 5: first-degree murder in the shooting death of Wayne Smith, aka Marlo Top, on July 19, 2023, to benefit, promote, or further the interests of a criminal gang.

Trayvon Key, Sigmund Brown, Gerard Charles, aka Hot Rod, and **Tyriq Jackson, aka Rico**, 10/19/2000, are charged with:

Count 6: first-degree murder in the shooting death of Dorothy Smart, on Sept. 13, 2023, to benefit, promote, or further the interests of a criminal gang.

Sigmund Brown, Kevaris Johnson and **Gerard Charles** are charged with:

Count 7: first-degree murder in the shooting death of Terrance Farrington, Jr., on Jan. 20, 2024, to benefit, promote, or further the interests of a criminal gang.

Kevaris Johnson and Rajah Rolle (Rolle, age 16, juvenile charged as an adult) are charged with

Count 8: first-degree murder in the shooting death of Johnnie Henderson, on Jan. 28, 2024, to benefit, promote, or further the interests of a criminal gang. (Maximum possible legal penalty for juvenile charged as adult is life in state prison.)

Trayvon Key, Sigmund Brown, Kevaris Johnson, Gerard Charles, Jared McCabe, Tyriq Jackson, and **Rajah Rolle** are charged with:

Count 9: Racketeering (RICO) between about June 1, 2020 and Aug. 30, 2024, through their activities in a criminal street gang, known as Dania Hot Boyz/Grand Mafia, and subsidiaries Junior Mafia, Go Getters, and Family Forever. The criminal actions included homicides, assaults and battery, firearm offenses, fraud, and security of communications.

Trayvon Key, Sigmund Brown, Kevaris Johnson, Gerard Charles, Vondarious Davis, Jared McCabe, Tyriq Jackson, and Rajah Rolle are charged with:

Count 10: Conspiracy to commit racketeering (RICO) between about June 1, 2020 and Aug. 30, 2024, by engaging in criminal gang activities including homicides, firearm offenses, assault and battery, and fraud.

Sigmund Brown is charged with:

Count 11: attempted first-degree murder by shooting at Dorothy Smart on Oct. 15, 2020, to benefit, promote, or further the interests of a criminal gang.

Count 12: unlawful use of a two-way communication device on June 18, 2021, to facilitate or further the attempted murder of Clinton Jones (Jr).

Count 13: attempted first-degree murder by shooting at Clinton Jones, Sr. on July 3, 2021, to benefit, promote, or further the interests of a criminal gang.

Count 14: attempted first-degree murder by shooting at William Griffin on July 3, 2021, to benefit, promote, or further the interests of a criminal gang.

Trayvon Key is charged with:

Count 15: unlawful use of a two-way communication device between June 16 and September 17, 2021, to facilitate or further the murder of Wisdom Williams.

Sigmund Brown is charged with:

Count 16: unlawful use of a two-way communication device on Sept. 17, 2021, to facilitate or further the attempted murder of Wisdom Williams.

Count 17: accessory after the fact in Sept. 17, 2021 murder of Wisdom Williams by Trayvon Key, to benefit, promote or further a criminal gang's interests.

Count 18: unlawful use of a two-way communication device between Sept. 11 to 14, 2021, to facilitate or further the attempted murder of Anthony Miguel Wright.

Sigmund Brown and Trayvon Key are charged with:

Count 19: shooting into an occupied dwelling on Dec. 15 in Fort Lauderdale to benefit, promote or further a criminal gang's interests.

Trayvon Key is charged with:

Count 20: unlawful use of a two-way communication device on Jan. 22, 2022, to facilitate or further the murder of Markie Florence.

Trayvon Key, Sigmund Brown and Jared McCabe are charged with:

Count 21: attempted first-degree murder by shooting at Rosiah Bordeaux, on Jan. 22, 2022, to benefit, promote or further a criminal gang's interests.

Count 22: attempted first-degree murder by shooting at Derrick Thomas on Jan. 22, 2022, to benefit, promote or further a criminal gang's interests.

Kevaris Johnson is charged with:

Count 23: possession of a machine gun, a Glock .40 caliber with a Switch, on March 1, 2023.

Trayvon Key and **Tyriq Jackson** are charged with:

Count 24: unlawful use of a two-way communication device from Feb. 3 to 12, 2022, to facilitate or further the murder of Dorothy Smart.

Jared McCabe is charged with:

Count 25: using electronic communication, via Instagram Live on Sept. 14, 2023, to intimidate or harass others by celebrating and claiming credit for the murder of Dorothy Smart the previous day.

Sigmund Brown, Kevaris Johnson and **Vondarious Davis** are charged with:

Count 26: conspiracy to commit the first-degree murder with a firearm of Azyiah Sumpter, to benefit, promote or further a criminal gang's interests.

Count 27: attempted first-degree murder with a firearm of Azyiah Sumpter by shooting into a building where they thought he was on Dec. 20, 2023. Bilnyia Ervin was shot and injured.

Kevaris Johnson and **Rajah Rolle** are charged with:

Count 28: attempted first-degree murder of Azyiah Sumpter by shooting into a vehicle where they thought he was on Jan. 13, 2024. Serenity Smith (5-year-old girl) was shot and injured.

Kevaris Johnson and **Rajah Rolle** are charged with:

Count 29: attempted first-degree murder of Azyiah Sumpter by shooting into a vehicle where they thought he was on Jan. 13, 2024. Derricka McCloud was shot at instead.

Sigmund Brown, Kevaris Johnson and **Gerard Charles** are charged with:

Count 30: attempted first-degree murder of Sara Margolis by shooting at her on Jan. 20, 2024.

Count 31: attempted first-degree murder of Luis Alberto del Valle Gonzalez by shooting at him on Jan. 20, 2024.

Kevaris Johnson and **Rajah Rolle** are charged with:

Count 32: attempted first-degree murder of Fanci Clark on Jan. 28, 2024.

Trayvon Key is charged with:

Count 33: possession of a machine gun, a Glock 9 mm with a Switch, on June 3, 2024.

(2) Counts charged, maximum possible penalties:

Counts 1 to 8: first-degree murder. Maximum penalty is life in state prison or death penalty, if sought. A panel of senior prosecutors will review all of the evidence and circumstances in the coming weeks and make a decision on whether to seek life in prison or the death penalty. Rolle is a 16-year-old juvenile charged as an adult so the maximum possible legal penalty for him, if convicted, is life in state prison.)

Count 9: racketeering (RICO). Maximum penalty is life in state prison.

Count 10: conspiracy to commit racketeering (RICO). Maximum penalty is 30 years in state prison.

Count 11: attempted first-degree murder. Maximum penalty is life in state prison.

Count 12: unlawful use of two-way communication device. Maximum penalty is five years in state prison.

Counts 13 – 14: attempted first-degree murder. Maximum penalty is life in state prison.

Counts 15 – 16: unlawful use of two-way communication device. Maximum penalty is five years in state prison.

Count 17: accessory after the fact (murder) Maximum penalty is 30 years in state prison.

Count 18: unlawful use of two-way communication device. Maximum penalty is five years in state prison.

Count 19: shooting into occupied dwelling. Maximum penalty is 15 years in state prison.

Count 20: unlawful use of two-way communication device. Maximum penalty is five years in state prison.

Counts 21 – 22: attempted first-degree murder. Maximum penalty is life in state prison.

Count 23: possession of a machine gun. Maximum penalty is 15 years in state prison.

Count 24: unlawful use of two-way communication device. Maximum penalty is five years in state prison.

Count 25: electronic communication. Maximum penalty is five years in state prison.

Count 26: conspiracy to commit first-degree murder. Maximum penalty is life in state prison.

Counts 27 – 32: attempted first-degree murder. Maximum penalty is life in state prison.

Count 33: possession of a machine gun. Maximum penalty is 15 years in state prison.

Vondarius Davis aka Von, 02/17/1995, case # 24011946CF10A, counts 10, 26 and 27.

Tyriq Jackson aka Rico, 10/19/2000, case # 24011943CF10A, counts 6, 9, 10 and 24.

Jared McCabe aka Hatch, 07/02/1999, case # 24011944CF10A, counts 5, 9, 10, 21, 22, and 25.

Rajah Rolle, 03/11/2008, 16-year-old charged as an adult– maximum penalty if convicted of first-degree murder is life in prison, case # 24011948CF10A, counts 8, 9, 10, 28, 29 and 32.
